

## **Iowa Whitewater Coalition Board Meeting Minutes**

### **Dam Safety Update:**

  - Quaker Mills low head dam remediation actions

  - Changes in the Elkader Whitewater park

**Paddling Instruction Update:** The following items were discussed:
